National Human Trafficking Prevention Month

January was declared "National Human Trafficking Prevention Month" in 2010 by previous President Barack Obama via a presidential proclamation. Fifteen years prior to this proclamation, the <u>Trafficking Victims Protection Act of 2000 (TVPA)</u> preserved the United States' dedication to combating human trafficking. Since the presidential proclamation and the enshrinement of TVPA, there have been significant U.S antitrafficking policy achievements such as the release of the updated <u>National Action Plan to Combat Human Trafficking in 2021</u>.

Health information technology (HIT) is a crucial tool for healthcare systems to coordinate care for patients, yet there are privacy concerns unique to people who have experienced intimate partner violence (IPV) and exploitation. With potential impact to a patient's care utilization and engagement, this is not just an issue of privacy but also one of safety.

Included here are guiding principles that should be applied by healthcare providers, administrators, policy makers and developers when designing, building, utilizing or regulating health information systems that will hold or exchange sensitive health information.

New Resources from Health Partners on IPV + Exploitation

Health Partners on IPV + Exploitation recently published two new resources that can be found in our resource library:

- A Practical Guide on Intimate Partner Violence, Human Trafficking, and Exploitation and Technology Tools
 - This resource was developed in collaboration with HITEQ and features tools and principles to help Health Centers (HCs) develop safe documentation for intimate partner violence, human trafficking, and exploitation (IPV/HT/E) in their electronic health records (EHRs) and other technology tools.

Collaborative Responses to Human Trafficking:

Quality Assessment/ **Quality Improvement** Tool (QA/QI)

This QA/QI tool is intended to provide health centers with guiding questions to assess quality of care related to promotion of healthy relationships and intervention related to intimate partner violence (IPV), human trafficking (HT), and exploitation (E) within their health care delivery.

Sample Health Center Protocol

This adaptable protocol aims to prevent exploitation, human trafficking, domestic violence, and intimate partner violence by helping patients have health relationships and promote their health. The protocol, available in English and Spanish, enables health centers to provide traumainformed, survivor-centered care; intervene with clinical and case management services; and formalize ways to connect patients with community-based services.









- Enhancing Emergency Preparedness in Health Centers for Addressing IPV, HT, and Exploitation
 - This 4-page educational brief outlines strategies for enhancing emergency preparedness in HCs, focusing on IPV/HT/E.
